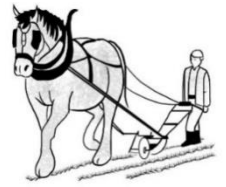

8.1 24/0575/FUL - Installation of an underground grid connection cable within the highway verge and 300m of agricultural land located between the consented Hill Farm Solar Farm (Blaby District Council LPA ref. 21/1386/FUL) and Clump Farm Solar Farm (Hinckley and Bosworth Borough Council LPA ref. 21/01242/FUL) to the point of connection at Enderby Substation, Desford Road, Enderby, LE19 4AD. Location: Highway Verge And Agricultural Land On Leicester Road /Hinckley Road (A47) And Desford Road (B582) Between Thurlaston And Enderby.
